## PRESENTATION OF PAPERS

Participants are expected to present a Country Status Report and/or a research/scientific paper on any of the themes appropriate to the Conference.

## PUBLICATION OF THE PAPERS

A publication edited by one or more international experts and based on the papers presented by the participants during the Conference and also containing papers contributed by other eminent experts in the field will be brought out in the form of a book as a follow-up of this programme. Therefore, all participants are requested to submit the manuscripts of their full papers in **MS-Word** format only well in advance, but latest by **October 30, 2023**. A copy of the “Author’s Guidelines” is also attached. The book will be published by a reputed International Publishing House.

## SELECTION OF APPLICANTS

Selection of applicants will be made based on their academic and professional backgrounds. Successful applicants will be electronically informed about their selection and other important details.

For exceptional cases, the participants may be allowed to attend the conference virtually. Details about the virtual platform will be provided well within the time after the selection procedure is completed. Other details and terms and conditions of participation will be given to the individual candidates on receipt of their applications.

### **LOCAL HOSPITALITY AND TRAVEL**

Local hospitality in Mauritius including accommodation, meals and local transport for the foreign participants sponsored by the NAM S&T Centre will be provided from **20 November 2023 [Noon] - 24 November 2023 [Noon]** (i.e. from one day before the commencement to one day after the completion of the Conference). The participants are requested to book their flights accordingly; otherwise, they will have to make their own arrangements to stay beyond these indicated dates.

### **FINANCIAL ARRANGEMENTS FOR TRAVEL**

The financial terms and arrangements for international travel of foreign participants will be conveyed to individual applicants on receipt of the Application Form along with other required documents.

### **ENTRY FORMALITIES AND IMMIGRATION**

Participants of the Conference must be in possession of a current passport or any other internationally recognized travel document, which must have a **period of validity of at least six months beyond the period of stay in Mauritius** and must be endorsed for travel to Mauritius.

Participants should have a valid visa for entry into Mauritius. The Mauritius diplomatic mission located in the country of the participant should be approached for obtaining an entry visa. For a large number of countries, however, online visa application is required. If required, the organizers will facilitate the issuance of visa by providing the participants with an official letter of invitation.

*\*Note: The governments/institutions of the selected participants will be required to bear the following costs:*

- All expenses in the home country incidental to travel abroad, including expenditure for passports, required medical examinations, vaccinations and miscellaneous expenses such as internal travel to the airport of departure in the home country.
- Salary and other related allowances for the participants during the period of the Conference.
- Cost of medical insurance to cover the period of participation in the Conference.

*The organizers of this Conference will not assume responsibility for the following expenditure in connection with the participant's attendance in the Conference:*

- Expenses incurred with respect to any insurance, medical bills or hospitalization fees.
- Compensation in the event of death, disability or illness of participant.
- Loss of personal belongings or compensation for damage caused to them by climatic or other conditions.
- Other costs, including visa fee, airport taxes and excess baggage fee, etc.
